Yn ystod y bore, cerddodd sawl rhiant a phlant trwy ganol maes parcio'r ysgol, tra bod traffig o gwmpas. Peidiwch â cherdded trwy ganol y maes parcio - defnyddiwch y llwybrau.

- **NID oes rhieni/neiniau a theidiau/perthnasau i gerdded trwy faes parcio'r ysgol.**
- **NID yw maes parcio'r ysgol ar gyfer cerddwyr.**
- **Mae POB rhiant / neiniau a theidiau / perthnasau i ddefnyddio'r llwybrau troed o'r giât uchaf neu'r giât isaf i bwyntiau mynediad yr ysgol.**
- **DIM rhieni/neiniau a theidiau/perthnasau i ddefnyddio maes parcio'r ysgol heb ganiatâd ymlaen llaw.**
- **Rhaid i bob rhiant sydd angen defnyddio'r maes parcio wneud cais ysgrifenedig i postglanrafon@hwbcymru.net.**
- **Gall pobl sydd â bathodynau glas i'r anabl ddefnyddio'r maes parcio.**

Mae opsiynau posibl yn y dyfodol i leihau'r risgiau yn cynnwys

- **Cau'r giât rhwng 8:45am-9.15am/diwedd y dydd, mynediad i dacsis yn unig.**
- **Gosod gatiau awtomatig**
- **Plismona'r giât**

Following a health and safety audit this morning (following FCC requests for carpark risk management evidence) with Compliance Education and a school governor, several **serious** issues have been noted regarding the school car park. During the morning, several parents and children walked through middle of the school car park, whilst there was traffic all around. **PLEASE** DO NOT use the car park - use the paths.

- **NO parents/grandparents/relatives are to walk through the school car park. The school car park is NOT for pedestrians.**
- **ALL parents/grandparents/relatives are to use the footpaths from the top gate or bottom gate to the school entry points.**
- **NO parents/grandparents/relatives to use the school carpark without prior permission.**
- **All parents who need to use the car park must apply in writing to postglanrafon@hwbcymru.net. People with disabled blue badges can use the car park.**

Possible future options to minimize the risks include

- **Closing the gate from 8:45am-9.15am/end of the day access to taxis only.**
- **Installation of an automatic gates**
- **Policing the gate**
